BOLSA MEXICANA DE VALORES, S.A.B. DE C.V INFORMS: Methodology Changes to the BMV Rentable and Economic Activity Indices.

BMV Rentable

The index committee has determined that the annual rebalance scheduled for December 2016 will no longer take place and instead the next annual rebalance will be effective after the market close on the third Friday of March 2017. The rebalancing reference date for the March 2017 annual rebalance will be the last business day of February. In addition, starting in the year 2017 the index will be re-weighted after the market close on the third Friday of June, September and December.

BMV Economic Activity

- The expected effective date for these changes is June 19th, 2017.
- The annual constituents review schedule will change from being effective after the close on the last business day of May to the third Friday in June. The new rebalance reference date will be the last business day of May. In addition, the index will be re-weighted after the market close on the third Friday of March, September and December.
- The index committee reserves the right to change the thresholds for capping limits as market conditions require it.
- This announcement is a clarification of the previously announced sector list for the Economic Activity indices.

Following, is the detail of the eligible sectors that will constitute each Economic Activity Index. Companies classified under these industries may become eligible to be included in the respective Economic Activity indices.
