The calculation in order to determine the number of shares and opening weightings for the new constituent list, has been made in compliance with the Injunctive Relief which BMV is subject to, therefore, the weighting for ELEKTRA was calculated according to IPC's methodology without the adjustments announced on April 11, 2012. For the remaining securities, BMV applied the methodology considering the adjustments announced on April 11th, 2012, and updated on February 12th, 2013, approved at its time by BMV's Technical Committee of Indices. The list of the 55 first stock series according to IPC's Eligibility criteria includes the information reported by the issuers as of July 2014 end of month and considers the operation filtering in order to calculate the turnover factor, in attribution to the faculties of the Indices Methodologies Technical Committee and the market notice published on April 11<sup>th</sup>, 2012
