## Prices and Quotations Index Rebalance

Preview – June 2015

### BOLSA MEXICANA DE VALORES S.A.B. DE C.V. INFORMS:

The preview of the number of shares and startup weightings for each stock series within the Prices and Quotations Index constituent list, due to the quarterly rebalance of the relative weightings, to be effective/valid since June 1<sup>st</sup>, 2015. This number of shares takes into account the considerations applicable due to the injunctive relief, promoted by ELEKTRA \* before the 6<sup>th</sup> Judge of México City, as stated in the market notice published in August 15, 2012 entitled **“Market Notice Change in the Sample of the IPC that will be used starting September 3rd 2012”**.

With data as of May 21<sup>st</sup>, 2015 close, no stock series had an individual relative weighting greater than 25% within the constituent list and the group of the 5 largest stock series had no cumulative relative weighting greater than 60%, for that reason, the corresponding rule for **“Maximum Weightings”** within the numeral **“V. Weightings and Floating Market Cap determination for each company within the IPC / MEXBOL 's constituent list”** contained in the Methodology Note\* of the Prices and Quotations Index (IPC), will not be applied.
