STNE) ( Stone or theCompany ) today announced that itsBoard of Directors has approved the payment of an extraordinary cashdividend of USD2.53 per share of the company (both Class A and Class Bshareholders) to be paid on May 4th, 2026 to shareholders of record as of April 24th, 2026. Based on shares outstanding on March 31st, the total amount of cash to be paid inthe dividend will be approximatelyRUSD3.08 billion. The board has also approved an increase of approximately 3.8mm of shares related to theLong Term Incentive Plan pool, which shall be settled in accordance with the vesting schedule of the respective incentives. The final amount will be announced through an S.8filling following the financial settlement of the dividends on May 4th.
